The Harvest Project program seeks to partner with and give wheelchairs to organizations that minister to people affected by disability in less-resourced countries.

Process:

- Complete the Harvest Project application form and return to Harvest Project Coordinator via mail, email or fax
- ☑ Describe your competency and capacity to provide wheelchairs in less resourced countries of the world
- ☑ Upon approval, applicants will be notified of next actionable steps

Criteria:

- ☑ Faith-based mission
- ☑ Valid non-profit designation/status
- ☑ Coordinate and fund transportation of wheelchairs domestically/internationally

Agreement:

- ☑ Appropriately fit/seat recipients in wheelchairs
- ☑ Share the Gospel with each wheelchair recipient and caregiver/family
- ☑ Facilitate inclusion into community through ongoing care and support
- ✓ Provide outcome report and photos to Wheels for the World

Consulting:

- Logistics
- ☑ Team formation, training and support
- ☑ Disability awareness and resources
- ☑ Organizations wanting to learn more can consult with *Wheels for the World* staff and receive hands-on training by joining a *Wheels for the World* Outreach prior to their own wheelchair provision plans. Donation of unrestored wheelchairs are welcomed.

Background/Purpose:

Whereas, JAF has offered to donate wheelchairs, medical supplies, and related items ("Donated Goods") as available to Donee, and

Whereas Donee wishes to accept such goods for ultimate distribution to the ill, the needy, youth or disabled, and

Whereas the parties with to set forth their mutual agreements and understandings with regard to donations intended to be made in the future.

Agreement:

Therefore, in consideration of the mutual promises contained herein, the parties hereby agree, and represent as follows:

1. Use of Goods.

- 1.1 Donee agrees to use the Donated Goods solely for projects within its organization relating to its taxexempt purpose and solely for the needy and people with disabilities.
- 1.2 Donee agrees to not offer for sale, sell, transfer or barter the Donated Goods by JAF in exchange for money, other properties or services unless written consent is received from JAF.
- 1.3 Donated Goods must be distributed by Donee to those in need, free of charge.
- 1.4 Donated Goods must be shipped or distributed internationally, and may not be distributed within the United States of America.
- 1.5 Donee agrees to abide by any restrictions on use or distribution of Donated Goods, geographical or otherwise, as required by JAF and communicated in writing to Donee by JAF.
- 1.6 Donee agrees to utilize employees or volunteers having sufficient training, expertise in evaluation, handling, adjusting, of Donated Goods to safely and properly judge, handle, prepare or use.
- 2. Disclaimer of Warranties. Donee acknowledges that all Donated Goods received from JAF are accepted by Donee in "as-is" condition and JAF makes no warranty, covenant or representation, expressed or implied, regarding the Donated Goods, including without limitation, their design or condition or fitness for any particular purpose. JAF shall not be liable for any direct or consequential damages or losses suffered or incurred by your or a third party as a result of the use of the Donated Goods.
- 2.1 Donee agrees and understands that it is responsible for the correct storage and use of the Donated Goods in accordance with the Donee waives any and all claims against and release JAF from all liability associated with the use of the Donated Goods.
- Reserved Rights of JAF. Donee understands and agrees that JAF reserves the right at any time, its
 good faith discretion, to rescind or modify this agreement or forbid Donee from receiving further
 donations from JAF.
- **4. Indemnification.** Donee hereby agrees to hold JAF harmless of any action, suits of law or in equity, or any obligation whatsoever arising out of or attributed to any action by the Donee in connection with its storage, use or transfer of the items supplied to it by JAF.
